COMMERCIAL HIGH EFFICIENCY NATURAL GAS FOOD SERVICE EQUIPMENT REBATE PROGRAM

Benefits & Energy Savings:

Consider upgrading your natural gas fryers, steamers, and convection ovens to ENERGY STAR®-qualified models and appreciate real savings in your pocket. These energy-efficient appliances “can save up to 50 percent over their conventional counterparts”, according to the ENERGY STAR web site. Not only will you save energy, you’ll help reduce greenhouse gases, which everyone can appreciate.

How to Participate:

Consult the Department of Energy’s ENERGY STAR web site for a listing of models that are eligible for the Commercial High Efficiency Natural Gas Food Service Equipment Rebate Program.

Once your new natural gas, high-efficiency food service equipment has been installed, review and complete the rebate application. Then attach a copy of all dated receipts or work orders that document the purchase and installation. Make sure that these receipts indicate the name, license #, address, and phone # of the contractor who completed the installation.

Please allow 4-6 weeks for your rebate request to be processed.

Program Guidelines:

- You must be a commercial, industrial or municipal customer of Connecticut Natural Gas Corporation, Southern Connecticut Gas Company, or Yankee Gas Services Company on a firm gas rate.
- All installations of high-efficiency food service equipment must be completed by a licensed contractor. All installations must conform to all applicable codes and be installed in accordance with all rebate Program Guidelines.
- All proof of purchase receipts, work orders or other documentation must include the contractor name, license #, address, phone #, installation cost, and an itemized description of the equipment, including manufacturer, model #, and Cooking Energy Efficiency, as applicable.
- All installations are subject to verification that the equipment has been installed and is operational.
- Please read all Terms & Conditions on the reverse of the rebate application.
- Rebate offers subject to change without notice. Some restrictions may apply.

1. Customer Eligibility

You must be a commercial, industrial or municipal customer of the Connecticut Natural Gas Corporation, Southern Connecticut Gas Company or Yankee Gas Services Company on a firm gas rate to qualify. This program covers products purchased and installed on or after January 1, 2010 through March 1, 2011. Details of this program, including incentive levels, are subject to change or cancellation without prior notice. This application, with required documentation, must be received by the Commercial High Efficiency Natural Gas Food Service Equipment Rebate Program and postmarked by March 31, 2011. Please call the Program Administrator at (860) 665-3292 for further details.

2. Installation Verification

Prior to honoring any rebate, the participating gas company reserves the right to conduct an on-site verification that the equipment has been installed according to Program Guidelines and is in operation. This site visit, and all aspects related to this site visit, are conducted solely for such purpose. The site visit is not a safety review, nor is it intended for any other purpose.

3. Warranties

The participating gas companies and the Rebate Administrator do not endorse, guarantee or warrant any particular contractor, manufacturer or installation.

4. Changes to the Commercial High Efficiency Natural Gas Food Service Equipment Rebate Program

Program is subject to change without prior notice, and rebate offers may increase or decrease at any time.

5. Tax Liability

Customers of the program may be subject to tax liability for the value of goods and services received through the program pursuant to state or federal income tax codes.

6. No Tax Liability to the participating gas companies and the Rebate Administrator

The participating gas companies and the Rebate Administrator are not responsible for any tax liability, which may be imposed as a result of receipt of the rebates provided by the natural gas utility to the customer.

7. Liability & Release

As part of the consideration for participating in the program, participant hereby releases and shall indemnify, hold harmless and defend the participating gas companies and the Rebate Administrator from any and all claims, losses, harm, costs, liabilities, damages and expenses (including attorneys' fees) of any nature whatsoever arising directly or indirectly out of or in connection with the installation of high-efficiency equipment at the premises or any material and labor required for such installation.

Frequently Asked Questions

1. What is the purpose of the Rebate Program?

The purpose of the program is to encourage customers to purchase and install energy-efficient equipment through the Connecticut Energy Efficiency Fund (CEEF). A rebate is provided through your gas company to cover a portion of the additional cost for purchasing the energy-efficient equipment versus standard-efficiency equipment.

2. How can I recognize this equipment?

A customer or contractor who is uncertain about whether equipment meets the efficiency criteria should check with a local distributor or manufacturer. For questions regarding eligible equipment, please call the Commercial High Efficiency Natural Gas Food Service Equipment Rebate Program Administrator at (860) 665-3292 or contact your contractor.

3. Where can I find a contractor to install the equipment?

Refer to the ENERGY STAR® web site at www.energy-star.gov for tips on how to find the correct contractor, and check the local Yellow Pages for a complete list of licensed contractors who specialize in commercial food service equipment systems.

4. When will I receive my rebate?
